# Waivers & Conditions

1. The Executive Director of Camp Evergreen reserves the right to dismiss a camper who, in the opinion of the Executive Director, is a hazard to the safety and rights of others, or who appears to have rejected the reasonable controls and discipline methods of Camp Evergreen.
2. The Executive Director also reserves the right to deny the application or admittance of any camper who: a) is unable to demonstrate that he or she meets the prerequisites of the program to which he or she has applied; or b) is deemed unsuitable for the program to which he or she has applied.
3. The parent or guardian of a child ("camper") certifies that all behavioral issues, practices and habits (including abnormal behavioural problems) of the camper have been previously disclosed in writing to the Executive Director of Camp Evergreen, and that the camper and the parent/guardian will accept any necessary discipline that Camp Evergreen staff deems appropriate for the camper. In the event that an applicant camper does have behavioural problems, that camper will only be accepted into a Camp Evergreen program when the Executive Director and the parent/guardian have reached a clear agreement about the care required by the camper and the Camp's ability to provide that necessary care. Camp Evergreen reserves the right not to accept any camper with behaviour problems or issues that Camp Evergreen is unable to deal with properly.
4. The parent/guardian submitting the application for the camper hereby certifies that he or she is the person who has legal custody over the camper, and has the authority to make all decisions (including all medical decisions) concerning the camper. The parent or guardian also agrees that he or she has fully disclosed in writing to Camp Evergreen the conditions of custody, if applicable, for the camper, and has provided Camp Evergreen with photocopies of all court orders dealing with custody and visitation rights for the camper.
5. While every precaution is taken for the safety and good health of our campers, the parent or guardian of the camper acknowledge and agree that Camp Evergreen, its directors, and staff members, as well as the employees of facilities outside the camp facility are hereby released from all liability in the event of an illness, injury, accident or misfortune that may occur to the camper. The parent or guardian of the camper also acknowledge and agree that the Alberta Conference of Mennonite Brethren Churches and its directors are hereby released from all liability in the event of an illness, injury, accident or misfortune that may occur to the camper. The parent or guardian of the camper acknowledges that the camper is fully covered by Provincial Health Care or equivalent medical insurance, and has disclosed all particulars of this coverage to Camp Evergreen in writing.
6. The signature of the parent or guardian on this application gives permission to and authorizes Camp Evergreen and/or its designates to transport the camper off-site for various program activities or in search of medical attention. The signature of the parent or guardian also authorizes the Executive Director as well as staff members of Camp Evergreen to arrange for any special services or requirements necessary for the best interests of the camper. The signature of the parent or guardian also authorizes the Executive Director as well as staff members of Camp Evergreen to approve and obtain medical attention necessary for the camper's welfare and good health, and to make any medical decisions for the camper, including injection, anesthesia, or surgery. If a medical emergency should arise, Camp Evergreen will attempt to notify the parent or guardian of the camper as soon as possible. The parent or guardian of the camper acknowledges that he or she will responsible for paying any and all expenses that may be incurred for such services on behalf of the camper.
7. The signature of the parent or guardian on this application shall give Camp Evergreen the right to use pictures or videos of the camper for promotional purposes. If you do not want Camp Evergreen to use pictures of your child, please check "no" below.
